A copy of DGDE letter No.76/67/Expert Committee/C/DE/2018 Vol.II, dated 07.11.2019 alongwith its enclosures is forwarded herewith for your necessary action and strict compliance.

2. As per the recommendation of the Expert Committee MoD have decided vide their ID No.2(2)/2018-D(Q&C), dated 05.11.2019 that Cantonment Boards shall allow/permit construction of a w.c/toilet in existing buildings in absence of any such provision within that tenement to an authorized resident, subject to condition that proper sewerage connection to the said building already exists in the Cantonment. The Committee has further recommended that area of such toilet should not be more than 1.8 sqm and the width should not be less than 900 mm.

3. It is advised that the decision of MoD be placed before the Board for information and adequate publicity may be given to these instruction for the benefit of all concerned.

4. Further you are directed to submit monthly report on such permission given to this Dte. under intimation to DGDE before 5th of every month.



Sub: Construction of w.c/toilet in tenements in Cantonment areas

The Expert committee on working of Cantonment Boards, in its report submitted to the Government, has recommended that a toilet, being a basic utility, should be made available in each tenement in a Cantonment. The Committee has further recommended that area of such toilet should not be more than 1.8 sqm and the width should not be less than 900 mm.

2. The MoD, vide their ID No. 2(2)/2018-D(Q&C) dated 05.11.2019 have accordingly decided that the Cantonment Boards shall allow/permit construction of a w.c/toilet in existing buildings in absence of any such provision within that tenement to an authorized resident, subject to condition that proper sewerage connection to the said building already exists in the Cantonment.
3. Accordingly, instructions may be issued to all the Cantonment Boards under your jurisdiction to take necessary action as above. The conditions as mentioned in para 2 above, must be strictly complied with.
4. Above instruction of MoD may be placed before the Board for information and adequate publicity may be given to these instruction for the benefit of all concerned.
5. Monthly report on such permissions be obtained by Dtes., under intimation to this Directorate General.
6. DGDE has approved.
