**1. DECLARATION OF BABINA CANTONMENT AS ODF**

Reference CBR No. 09 dated 28/10/2017.

It is informed to the Board that the objections/suggestions from general public for declaring Babina Cantonment as Open Defecation Free were invited through newspapers vide this office Notice No. एफ04/5005/ओ.डी.एफ./बबीना/897, दिनांक 25.10.2017 published on 26/10/2017 in the "Dainik Jagran, Jhansi" and "Amar Ujala, Jhansi" and also uploaded on official website. In response to this office public notice, only one objection/suggestion has been received from Smt. Sushila Devi, Vice President Cantonment Board, Babina by this office on 09/11/2017.

It is also informed to the Board that all other Ward Members have already declared own wards as ODF vide above referred CBR and the Board has installed/constructed sufficient PGLs and Bio-Toilets in the Ward No. IV including other wards as per norms prescribed by the Ministry of Urban Development Ministry, Govt. of India and QCI have been approached for inspection.

Therefore the Board may declare Babina Cantonment as Open Defecation Free (ODF).

In this connection objections/suggestions dated 09/11/2017 received from Smt. Sushila Devi, Vice President Cantonment Board, Babina and relevant file together with report of Sanitary Inspector (Civil) is placed on the table.



1. **RESOLUTION:** - The Board considered the matter in detail. The Member-Secretary/CEO informed the Board that all elected members have already declared their wards Open Defecation Free except Ward No. IV. All the Schools situated in Cantonment area have also declared Open Defecation Free. It is also informed the Board that objections/suggestions from the general public for declaring Babina Cantonment as Open Defecation Free were invited through local newspapers and official website but no objections/suggestions received from general public and only one objections/suggestions dated 09/11/2017 has been received from Smt. Sushila Devi Rai, Vice President, Cantonment Board, Babina. The CEO called Sanitary Inspector who has submitted report regarding Ward No. IV that sufficient PGL and Bio-toilets have been constructed/installed as per norms and people are using them. All elected members and other member present in the meeting supported the report. The Member-Secretary/CEO informed to the Board that sufficient PGLs and Bio-toilets etc. have been constructed/installed in respect of all wards as per norms prescribed by Ministry of Urban Development, Govt. of India. The Board considered the objections/suggestion received from Smt. Sushila Devi Rai, Vice President, Cantonment Board, Babina. Thereafter Shri Ravi Bharti, Elected Member informed the Board that he has not signed ODF certificate and he filed objections/suggestions dated 13/11/2017 which were invited through newspapers from the general public within a period of 15 days from the publication of general notice for declaration of Babina Cantonment as ODF published on 26/10/2017 in the local newspapers. The Member-Secretary/CEO informed to the Board that as per record available with the Board that he (Mr. Ravi Bharti) has already declared his own ward i.e. Ward No. VI as ODF and signed the ODF certificate on 16/10/2017 and as regard objections/suggestions filed by him it is informed to the Board that his objections/suggestions received by this office on 13/11/2017 which is time barred and merit less being filed by him after expiry of period of 15 days. Therefore the Board has considered the objections/suggestion dated 13/11/2017 received from Shri Ravi Bharti, Elected Member is rejected being time barred and merit less. After detailed discussion, the Board declared that Babina Cantonment becomes Open Defecation Free following the protocol and such declaration regarding ODF be informed to the Govt. of India and respective Ministry. The Board authorized the CEO to levy a fine on any person found defecating in open within Cantonment area. The Board further authorized the CEO to install bio-toilets and urinals etc. according to the further requirement in Cantonment area. The Board also authorized CEO to appoint Swachhta Prahari to inspect Cantonment area to prevent Open Defecation.

2. **CIVIL MISCE WRIT PETITION NO. 42701 OF 2017.**

To note the Judgment dated 13/09/2017 passed by Hon'ble High Court Judicature at Allahabad in the Civil Misce Writ Petition No. 42701 of 2017 filed by Rajveer Singh, Head Master, Cantonment Board, Primary School, Babina regarding enhancement of age of retirement of teachers for further 02 years after their retirement age of 60 years at par with U.P. State Govt.

It is informed to the Board that a Civil Misce Writ Petition No. 42701/2017 has been filed by Shri Rajveer Singh, Head Master, Cantonment Board, Babina against three months Retirement Notice dated 29/08/2017 under section 8 (1)(C)(2) of the Cantonment Fund Servants Rules, 1937 and the Rule 59 (1) (C) of Pension Rules served upon Shri Rajveer Singh vide this office letter No.पें.फा./राजवीर सिंह/प्र.अ./721, दिनांक 29/08/2017 before the Hon'ble High Judicature at Allahabad regarding enhancement of age of retirement of teachers of Cantonment Board School Teachers from 60 to 62 years as per U.P. State Govt. teachers. The Hon'ble High Court Judicature at Allahabad Order dated 13/09/2017 wherein it is mentioned that "Till then the effect and operation of the impugned notice dated 29.08.2017 shall remain stayed. No interference shall be caused in the functioning of the petitioner till then.
